- o Have borrowed in violation of the annual or aggregate loan limits
- o Have previously received a baccalaureate or professional degree
- o Have been convicted of any offense under any Federal or State law involving the possession or sale of a controlled substance for conduct that occurred during a period of enrollment for which the student was receiving any T4 aid

7. Any instructions, directions, or guidance provided by the institution to students concerning the Emergency Financial Aid Grants.
